#### FINANCIAL REPORT

Judith Blahnik reported AFTER final payments to 12-13 contracts approximately \$26,666 will roll over remaining. Blahnik said she expects the Advisory Committee to approve a 2013-14 budget in July or August.

## FIRST THURSDAY ARTWALK SUBCOMMITEE:

Pat Carroll reported the subcommittee suggested other night time events to take the pressure off the ArtWalk of being the only regular crowd-drawing event downtown—perhaps a 3<sup>rd</sup> Thursday or 2<sup>nd</sup> Saturday for Classic Cars downtown. Varied themes each month. It was **AGREED** that John Stinson, Madeleine Drake and Pat Carroll would work the concept into a grounded proposal. Michael Gatanz reported that the First Thursday music venues website will launch as scheduled at August ArtWalk.

## **ACE ADVISORY COMMITTEE ELECTIONS**

Judith Blahnik reminded all that elections to the advisory committee would be held at the upcoming meeting in July. She stated that there were 6 seated at large members and 4 at large members who must seek re-election if they wish to serve. There were also 4 more at large seats available. Blahnik asked members to distribute candidacy forms to anyone they thought might consider serving.

#### **BUDGET 2013-14**

Judith Blahnik requested approval of a 3-month (July-September) contract extension to Findings Art Center for First Thursday ArtWalk Support and to Grand Vision Foundation for Arts District San Pedro website. This would provide uninterrupted activity while the Advisory comes to clarity about the budget allocations for the coming 2013-1014. Linda Alexander made the motion to extend present contracts of Findings First Thursday Support and Grand Vision Foundation website maintenance for 3-months-July-September 201. Linda Grimes seconded

PBID Executive Director, Steve Robbins reported PBID awaiting final permit from City to extend LED lights not only to the LOFTS but from 4<sup>th</sup> street to 10<sup>th</sup> on Pacific Avenue; received permit for sidewalk usage; received approval to extend window graffiti program; DWP alley lighting completed; Travelers radio is up and running 1610 on the dial; Cirque du Soleil coming to Lane Victory pier in October.
